# **BENEFIT HIGHLIGHTS**

All benefits changes are effective January 1, 2023.

# The open enrollment period begins October 12 and ends October 31.

If you do not submit new elections, your current benefits will automatically carry over to the new plan year. The only exceptions are health savings accounts (HSA) and flexible spending accounts (FSA), which must be re-elected every year.

## How to enroll:

1. Call the Benefits Support Center at 833-782-7404.

Benefits counselors are ready to assist you. During open enrollment, the Benefits Support Center will be open for extended service hours October 12–31, 2022, Monday–Friday from 8 a.m. to 8 p.m. ET. After open enrollment, it will re-open for general benefits questions Monday–Friday from 9 a.m. to 5 p.m. ET.

- 2. Visit employeeconnects.com/ centurion to schedule an appointment with a benefits counselor.
- 3. Self-enroll by logging into YourCenturion.com.

Your username is your last name followed by the last four digits of your SSN (e.g. Smith8901). The first time you log in, your password will be your date of birth, eight digits, no spaces, no dashes (e.g. 12311986 for December 31, 1986). If you encounter problems, please call 833-782-7404.
